Sir/Madam,

With reference to the above, it is to inform that as per NCTE Regulations, 2014 a revised recognition order no. WRC/APW00585/323184/2015/142501 dt. 31.05.2015 was issued to the institution for conducting B.Ed. course of two years duration with an annual intake of 100 seats (two basic units of 50 students) from session 2015-2016.

The WRC in its 294^{th} meeting, held on July 4^{th} – 5^{th} , 2018, considered the Appellate Authority order dt. 05.06.2018 alongwith reply dt. 22.06.2018 submitted by the institution and decided as follows:

"The case file was seen. This is a case of appeal. The Appellate Authority vide order dated 05.06.2018 has remanded the case to WRC for further processing the application.

The institution vide letter dated 06.06.2018 has fulfilled all the requirements. However, the staff list contains only one Principal and eight faculty members which is sufficient for one unit.

Hence, Recognition is restored for one unit."

Therefore, the <u>recognition granted to the institution for conducting B.Ed. course has been restored</u> and <u>the institution is permitted to continue the existing B.Ed. course of two years duration with an annual intake of 50 seats from session 2018-19.</u>

It is also informed that the institution shall continue to follow the NCTE Regulations, 2014 and any deviation from it will be liable for action, against the institution, as defined under NCTE Act, 1993 and NCTE Regulations, 2014.
